Otterbein MBA and Columbus College of Art and Design Students Collaborate on "Smart Cities" Project

Otterbein MBA students Kamilah Twymon and Gaven Hale are partnering with students from Columbus College of Art and Design to work on a graduate studies project related to smart cities. Twymon and Hale will be joining CCAD Master of Design and Master of Fine Arts students in a semester-long project as part of their coursework at Otterbein.

New Orientation Event for Incoming MBA Students

The MBA program has designed a new orientation event for incoming students. Students will attend a half-day or day-long immersion workshop prior to their first semester, which will introduce them to key aspects of what they will experience during the program. Areas will include collaboration, design thinking, leadership, data analysis, project work, business design, entrepreneurship/intrapreneurship, etc. The goal is to better prepare incoming students to be aware and take advantage of all the value-added aspects of the Otterbein MBA.
