<b>Article III. Functions of the University Senate</b>
<b>Section 1.</b> The University Senate shall act as a legislative body in such affairs as are delegated to it by the Board of Trustees. These shall include, but not be limited to, the following:
A. to assist in establishing the educational aims and purposes of the University;
B. to establish, subject to the approval of the Board of Trustees, academic standards and policy for the admission, retention, and graduation of students;
C. to establish, subject to the approval of the Board of Trustees, the curriculum necessary to achieve the educational aims of the University, as well as to review periodically that curriculum;
<del>D. to establish, subject to the approval of the Board of Trustees, policies and regulations affecting student welfare such as housing, food, health, dress, general behavior, the Campus Center and bookstore</del> <i>review recommendations from Student Council regulations and make recommendations to the appropriate administrators or the Board of Trustees</i>

<b>Section 2.</b> <i>In addition, the University Senate supervises the work of standing and ad hoc committees of the University Senate</i>

**Section 3.** The University Senate also has responsibility to develop and maintain channels and processes for communication between University Senate and other components of University governance: the Board of Trustees, the standing and ad hoc committees of University Senate, and the various constituencies of the University Senate, including faculty, students, administrators, and staff.
