On July 2, 1776, the Second Continental Congress voted for the legal separation of the 13 Colonies from Great Britain by approving a resolution proposed by Richard Henry Lee, a delegate from Virginia. Mr. John Adams, the future second president of the United States, wrote the following to his wife Abigail on July 3<sup>rd:</sup>

The second day of July, 1776, will be the most memorable epoch in the history of America. I am apt to believe that it will be celebrated by succeeding generations as the great anniversary festival. It ought to be commemorated as the day of deliverance, by solemn acts of devotion to God Almighty. It ought to be solemnized with pomp and parade, with shows, games, sports, guns, bells, bonfires, and illuminations, from one end of this continent to the other, from this time forward forever more.

Although the Declaration of Independence was formally ratified on the fourth, the words of John Adams hold true. Year after year, throughout the generations, Americans have faithfully marked the birth of our country with festivities, fireworks and family gatherings. We have much to celebrate as an Otterbein community as well. Whether you choose to spend Independence Day with friends and family or by just having quiet time alone, I wish you a wonderful 4<sup>th</sup> of July holiday!

## **Organizational Structure Changes Announced**

At the May 17, 2014, meeting of the Otterbein Board of Trustees, the strategic plan for Otterbein University was finalized and approved. The strategic plan affirms the University's Strategic Priorities and Goals including:

- Enhance Student Success
- Strengthen Academic Excellence

- Build a Model Community
- Improve Financial Strength

In an effort to improve the alignment of the organizational structure with strategic priorities, I am pleased to announce the following organizational changes:

Effective July 1, 2014, the Student Accounts Office, currently a service area of the Division of Business Affairs, will report to the Division of Enrollment Management under the direction of Vice President for Enrollment Management Jefferson Blackburn-Smith. The Student Accounts Office is staffed by Judy Ralph, Vicky Degen and Kelly Dolin. Beyond a simple co-location of Student Accounts and Student Financial Aid in Barlow Hall, with this reorganization the University will establish an Office of Student Financial Services, giving students a single office to visit to manage their financial aid and account. Judy Ralph and Vicky Degen will move to this new office in Barlow Hall this summer. Kelly Dolin will continue to oversee the cashier function. Cashier and accounts receivable functions will remain with the Controller's office located at 25 W. Home Street. The goal of this re-alignment is to improve service to our students which ultimately **enhances student success**.

Also, effective July 1, 2014, the Office of Human Resources will report to the President's Office under the direction of Kristine Robbins, Chief of Staff. This change in reporting relationship will highlight the strategic priority of **building a model community** which includes investing in human resources. Ms. Robbins has more than 25 years of experience in the field of human resource management in both the

public and private sectors with the last 10 years focusing on leadership and professional development. The physical location of the Office of Human Resources will remain at 25 W. Home Street. The partnership between Business Affairs and Human Resources will continue to be essential in areas including compliance, total compensation, and risk management.

The Division of Business Affairs will continue to focus on the strategic priority of **improving financial strength** as we establish a sustainable model for Otterbein University, improve core business systems and processes, and manage and allocate resources in accordance with strategic priorities.

The Division of Business Affairs will consolidate the former Service Department , Mail and Printing Services, and the Bookstore to become the Office of Facilities Management and Planning under the leadership of a new Executive Director for Facilities, Planning and Management. This new position to be filled this summer is supported by the consolidation of vacant positions within the division. This new leadership position will focus on institutional planning and management to support those responsible for facilities and auxiliary operations. This position will refine the organizational structure to support effective stewardship of existing assets, progress toward identified master plan concepts and high quality service to academic and administrative offices. Additionally, this position will support the Vice President in various community engagement efforts. This change will strengthen efforts to **improve financial strength** and **build a model community**.

In an effort to better protect the financial, physical, human and environmental resources of Otterbein, the University will coordinate risk management efforts through the Division of Business Affairs under the leadership of Kalinda Watson, Director of Risk Management. The newly created Risk Management Office (RMO) will manage environmental health and safety, University contracts, and coordinate efforts to prevent, minimize and control the risk of damage and loss to the University's employees, students, physical and financial assets through the identification and analysis of risk and development and implementation of programs, policies and procedures. Ms. Watson and Tara Grove will staff the RMO. Ms. Grove formerly served as the University's Chemical Hygiene Officer. In supporting the risk management initiative, Tara will serve an expanded role as the Environmental Health and Safety Officer focusing on: environmental compliance, occupational health and safety, radiation safety, regulated waste management, industrial hygiene, life safety and emergency response.

## Information Technology and Services (ITS) Update

We are pleased to inform you that the Information Technology and Services Department increased internet bandwidth by 50% so faculty, staff and students can now enjoy faster internet access and downloads. ITS also upgraded to the newest release of Blackboard Learn, so all the latest product enhancements and features are now available. In addition, ITS licensed the mobile app for iOS and Android smartphones and tablets. Faculty and students can now download the Blackboard Mobile Learn app for free on an unlimited number of devices.

## Enrollment Update

Below is an update from the Division of Enrollment Management:

**Summer registrations (749)** are up slightly from last year, both in headcount and credit hours. The increase reflects 23 additional undergraduates which is an almost 8% increase.

**Total fall registrations for** <u>continuing</u> **students (1,685)** are down 2.25% from last year in headcount and 3.29% in credit hours.

<u>New</u> students for Fall 2014: Graduate admits are up. Freshman confirmations are down. The freshman class will include more students of color, male students, and students from Columbus City Schools. Transfer confirmations are up slightly and adult registrations are down slightly. International confirmations which include both freshman and transfer students are up. Additional details will be forthcoming in August as we continue to work aggressively to recruit the class.
