Emphasized areas of focus:

- EMR Administrative Utilization
- Policy Development
- Leadership & Management

Goals

- 1. Achieve a better understanding of administrative roles that come with being a collegiate head athletic trainer.
- 2. Learn leadership and management skills and strategies.
- 3. Utilization of the emergency medical record (EMR) system, ATS, such as implementing the inventory function.
- 4. Be active in the process of developing and updating policies, programs and procedures.
 - a. Sport Physicals
 - b. Concussion Policy/Protocol
 - c. Policies & Procedures (P&P)
 - d. Standard of Practice (SOP)
- 5. Gain knowledge in budgeting and financial management.

Sports Physicals

- When it comes to reviewing physical time there are always questions that arise. What warrants the need for a physical?
- Creating a document allows for easier and quicker communication between AT's about what requires a physical, SCAT and SCT on physical day.



Heidelberg University Physical Day Requirements

Physical, SCAT & Sickle Cell Testing

- All freshmen and newcomers
 - If they have already been sickle cell tested, they must submit a hard copy during check-in day, email the results to their respective AT, or submit the results directly into their ATS profile.

New Physical Only

- Returners, including:
 - o Diabetics
 - o pHx of seizures or epilepsy
 - pHx of surgery and has not yet RTP
 - o pHx of cardiac issues/concerns
 - Syncope or near syncopal episodes
 - Chest pain or discomfort with exercise
 - Elevated BP
 - Current heart murmur
 - Arrhythmias/palpitations
 - Wolf-Parkinson-White syndrome

Family hx

- Death of a relative from cardiac complications or sudden death < 50 y.o.</p>
- Marfan Syndrome
- o Marks "yes" to "Do you have concerns you would like to discuss with a doctor"
- Born without or missing an organ (eye, testicle, kidney, etc.)

SCAT Only

Returners who sustained a TBI the previous academic year

Sickle Cell Testing Only

- · Returners who select "OPTION 2" on their ATS Sickle Cell Trait Reporting Form
 - Applies to graduating classes of 2024 & 2025 (they have the option to waive)

Development

Policy Development/Updates

- As a Head Athletic Trainer at Heidelberg University, it is their responsibility to develop and update the P&P.
- This is an example of just 1 policy Tyson and I worked on developing together.
- We are currently working on developing and updating the rest of the P&P.

Lightning and Inclement Weather Policy

For lightning and inclement weather, the sports medicine staff at Heidelberg University will follow the guidelines and policies as dictated by the National Collegiate Athletic Association (NCAA).

- Thirty-minute rule Competition or practice shall be suspended once lightning has been recognized or thunder is heard. It is required to wait at least 30 minutes after both the last sound of thunder and after the last flash of lightning is at least six miles away, and moving away from the venue. If lightning is seen without hearing thunder, lightning may be out of range and therefore less likely to be a significant threat. This significantly reduces the risk of local lightning flashes. Any subsequent lightning or thunder after the beginning of the 30-minute count shall reset the clock, and another count shall begin.

- Evacuation sites:
 - SAFE SHELTERS include: an enclosed structure with four grounded walls (i.e., school building, cars and/or buses)
 - UNSAFE SHELTERS include: a structure, often outside, without four grounded walls (i.e., trees, storage shed and dugouts, convertible vehicles, gators, golf carts, building overhang, etc.)

Table 1. Flash to Bang Method

AMOUNT AS A SMALL OF ASSAULT STREET, THE COLUMN	
If Thunder is heard	The Lightning is
5 seconds after a Flash	1 mile away
10 seconds after a Flash	2 miles away
15 seconds after a Flash	3 miles away
20 seconds after a Flash	4 miles away
25 seconds after a Flash	5 miles away
