Notice is hereby given that in pursuance of resolutions of the Board of Education of the Westerville Exempted Village School District, passed on the 5th day of June, 1958 and the 3rd day of July, 1958, there will be submitted to a vote of the electors of said School District at a regular election to be held therein on Tuesday, November 4, 1958, at the regular places of voting therein, the question of issuing bonds of said Board of Education in the amount of One Million Four Hundred Ninety Thousand Dollars (\$1,490,000) for the purpose of constructing a new fireproof high school building, improving existing fireproof school buildings, and providing equipment, furnishings and site improvements in connection therewith.

The maximum number of years during which said bonds are to run is twenty-

three (23) years.

The estimated average additional tax rate outside of the ten mill limitation as certified by the County Auditor is 3.9 mills for each one dollar of valuation, which amounts to 39 cents for each one hundred dollars of valuation.

A 55% AFFIRMATIVE VOTE IS NECESSARY FOR PASSAGE

Shall bonds be issued by the Board of Education of the Westerville Exempted Village School District, for the purpose of constructing a new fireproof high school building, improving existing fireproof school buildings, and providing equipment, furnishings and site improvements in connection therewith in the sum of \$1,490,000 and a levy of taxes to be made outside of the ten mill limitation, estimated by the County Auditor to average 3.9 mills for each one dollar of valuation, which amounts to 39 cents for each one hundred dollars of valuation for a maximum period of twenty-three (23) years to pay the principal and interest of such bonds.
