Useful Information

Open Access – the document and abstract become fully searchable via Institutional repository databases, Otterbein’s OneSearch, and via the internet through search engines like Google.

Embargo – When the Upload Authorization Form indicates that there is to be an **embargo** applied to a particular document, the title and abstract of the document will be fully available to the public for viewing, **but the full text of the PDF document will be hidden for the indicated period of time.** Faculty and students will have the option of imposing an embargo or delay on the student’s publication for the following time periods: 6 months, 1 year, or 2 years. After that time period passes, the PDF will become fully accessible and available for download. This addresses situations such as patent application, book contract negotiation, or other proprietary interests that are of concern.

Access to Embargoed Documents:

- Users who attempt to access embargoed papers will receive the following notice:
 - *The full-text of this paper is currently under embargo. It will be available for download on Sunday, April 20, 20__.*
 - Each structure will include this note explaining to users how to address access to embargoed documents:
 - *Some projects may be embargoed at the request of the author and their advisor, restricting access to the project until a specific date. Advanced access to embargoed projects is available to Otterbein community members upon request. Otterbein students, alumni, faculty, and staff may email library@otterbein.edu to request access - please include the title, author, and year of the project being requested along with your name, Otterbein affiliation, and email address.*
 - Our librarians and reference staff will respond to any requests:
 - If the email comes from an authentic Otterbein user (with an Otterbein.edu email address verified against the Otterbein Directory), the Librarian or reference staff will email a PDF of the requested paper to the user within 48 hours of the request.
 - If the requester indicates that they are alumni, the Librarian or reference staff will email Alumni Relations for confirmation before sharing the document requested. This may delay the process by several days.
- If the requester does not have a valid Otterbein username, the Librarian or reference staff will email the request to the document’s faculty advisor, who will make the final determination for granting access.
 - The Librarian or reference staff will respond to the requester, giving them the name of the faculty advisor and explaining that the process is now in the faculty advisor’s hands.
 - If the faculty advisor reaches out to the Librarian or reference staff indicating access has been granted, the Librarian or reference staff will then download a copy of the document and email it to the requester.
